The United States Probation Office for the Southern District of Illinois intends to procure treatment services for federal defendants and persons under supervision using Blanket Purchase Agreements (BPA) for services beginning October 1, 2025. The total duration of the BPA, including the exercise of four 12-month options, shall not exceed 60 months. BPAs are being solicited for the following:

**Substance Use Treatment:** required services may include, but are not limited to, urinalysis collection, assessments, substance use cognitive based counseling (individual, group, and/or family), and transportation.
